The situation of counterfeit and imitation goods, and intellectual property violations, including industrial designs concerning products of Khanh Hoa Salanganes Nest, Sanest, and Sanvinest, continues to increase, seriously impacting the Company's sales activities in the market. While market demand in Q4/2024 showed some prosper compared to Q3/2024, it still hasn't experienced strong growth in the final months of the year.

In Q4/2024, the Company enhanced product quality, launched products with increased bird's nest content, redesigned packaging with new, luxurious, and eye-catching technology, carried out stimulus and attractive promotional programs for sales channels. These efforts increased brand recognition for Sanest Khanh Hoa - the National Brand at sales points on the market, limiting the image of competitors, boost benefits, and reduce inventory pressure for retailers, distributors, and agents.

As a result, the after-tax profit for Q4/2024 in the Separate Financial Statements was VND 17,881 million (a decrease of 47.43% compared to the same period last year), and in the Consolidated Financial Statements was VND 12,469 million (a decrease of 49.67% compared to the same period last year).
