Khanh Hoa Sanest Soft Drink Joint Stock Company explains the after-tax corporate income tax profit in the 2024 Income Statement, which has decreased compared to the same period in 2023, as follows:

With the expectation that the economy will recover in 2024 after a series of years impacted by the pandemic and recession, the Board of Directors and the Executive Board Nuoc Gial of the Company set revenue and profit plan in line with the optimistic economic forecast at the beginning of 2024.

However, by Q3/2024, the market for the Company's bird's nest beverages showed signs of slowing down due to consumers tightening their spending, resulting in a significant decline in purchasing power. Furthermore, the situation of counterfeit products, fake goods, and intellectual property violations, including industrial designs, regarding Sanest and Sanvinest bird's nest beverages, remains complicated, significantly affecting sales activities in the market and contributing to high inventory levels at the Company's sales distribution channels.

Therefore, to reduce inventory pressure on the distribution system, continue improving product quality, modernize packaging designs, and launch Sanest and Sanvinest bird's nest beverages with increased bird's nest content to enhance competitiveness, the Company implemented various demand stimulation programs, increased product visibility on store shelves, and expanded the market coverage of Sanest and Sanvinest bird's nest beverages. Additionally, the distribution system and sales channels were streamlined for stable growth in the coming years. As a result, the Board of Directors and the Executive Board proactively collected shareholders' written opinions and was approved to adjust the projected revenue and profit for the full year of 2024.

With these strategic changes, the Company has achieved positive results, specifically: After-tax profit for 2024 in the Separate financial statements was VND 52,713 million (a

decrease of 50.7% compared to the same period last year), and in the Consolidated financial statements was VND 56,267 million (a decrease of 45.11% compared to the same period last year).
